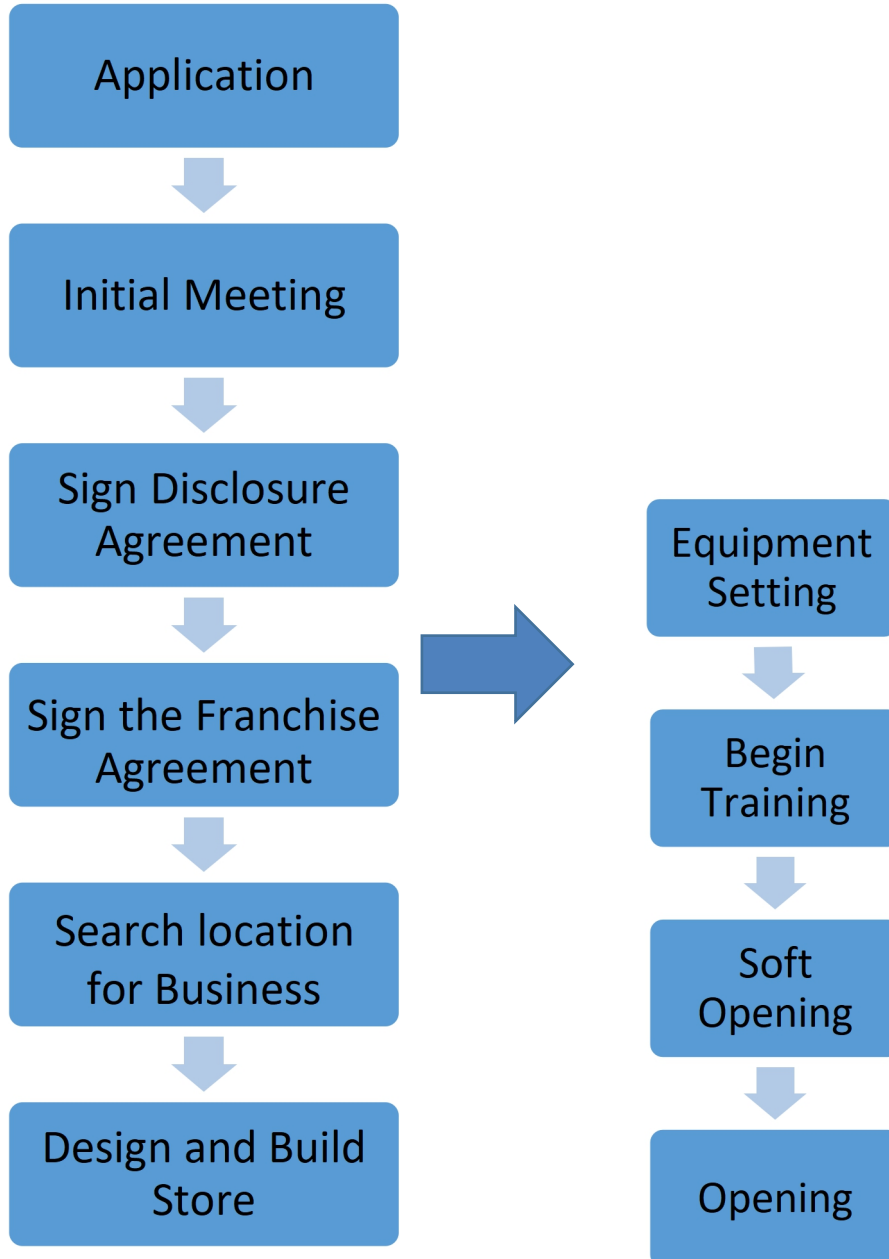

Step I-Application

To get started, fill out the initial application form on the website and contact the Edmonton head office. If you meet our minimum requirements to be a franchisee, we'll send you a franchise introduction and the full franchise application. Upon receipt of your application, we'll schedule your initial meeting with the Canada Quickly franchise team.

Step II - Initial Meeting

During this in-person meeting we'll review your application, discuss your business plans, and answer your questions about this opportunity to evaluate our compatibility. Next, you'll sign a financial disclosure agreement certifying your financial ability to meet our requirement.

Step III - Orientation

Depending on your proximity to existing Quickly locations, you may be invited to Orientation at the Canada Quickly Group in Edmonton to meet with senior executives and learn more about the Quickly franchise opportunity.

Step IV - Sign Franchise Documents

To finalize the application process, we'll conduct a complete background and reference check. Upon approval of your application, you and Canada Quickly Group will sign a franchise agreement. If at this time you do not have a site selected, the agreement will contain a condition for securing a mutually agreeable location.

Step V – Design and Build Quickly Store

The Quickly system is committed to developing restaurants in the best locations across the country. With our strong team empowered with growth-driven initiatives to find the location and size that best meets your financial goal and budget. Plus we will provide our franchisees with the most suitable interior design to bring customer the best experience.

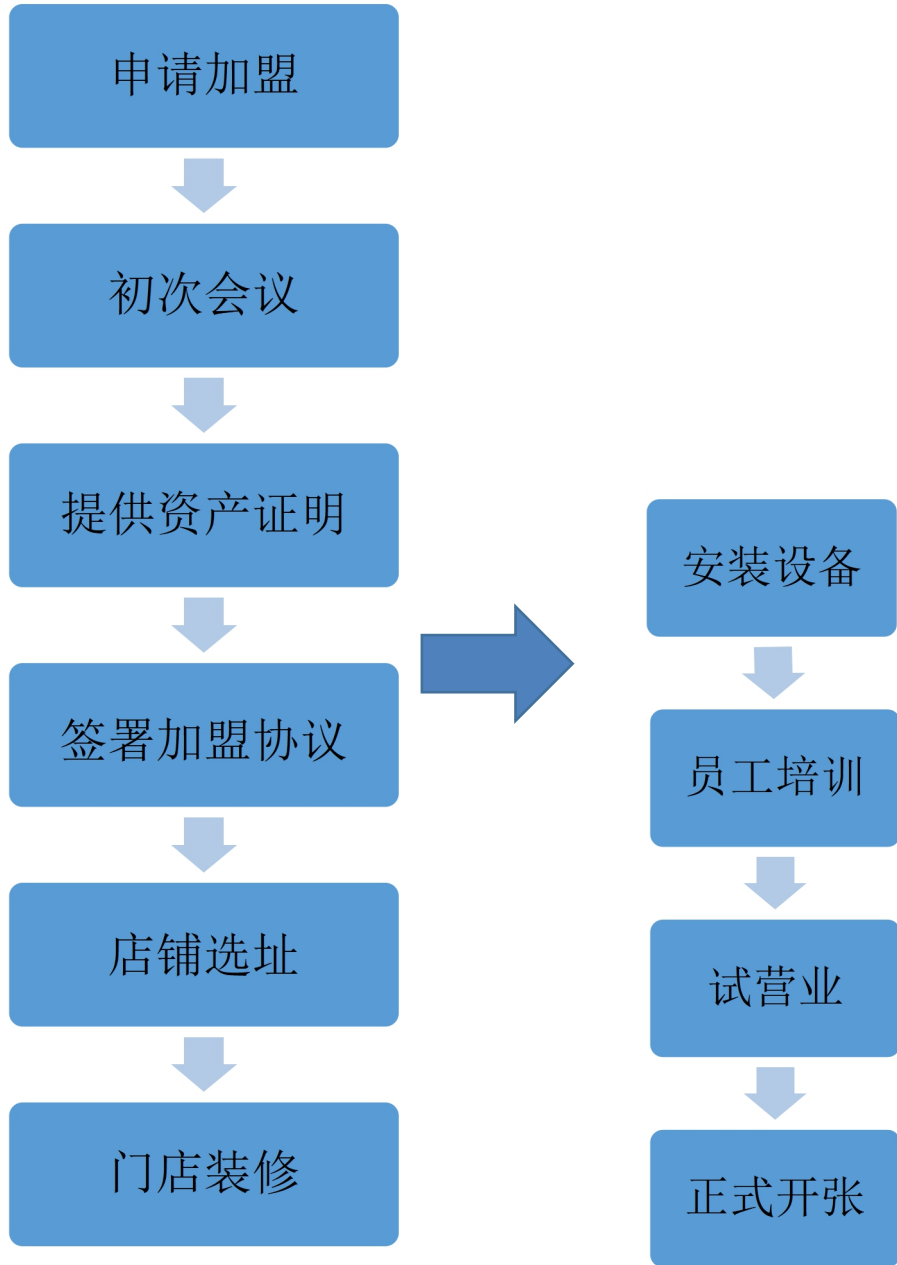

第一步-申请
